**No. KV – 23 of 2025 - UDUHD/COC/e-file/18/2024/5454/P Section -**  
WHEREAS, the Government of Gujarat, in exercise of the powers conferred by clause (2) of the article 243Q of the Constitution of India, has declared the areas of Nadiad Municipality and Gram Panchayats as specified in Schedule under the Government Notification, Urban Development and Urban Housing Department No. KV - 22 of 2025 - UDUHD/COC/e-file/18/2024/5454/P Section dated 01<sup>st</sup> January, 2025 (hereinafter referred to as 'the said Notification') to be the larger urban area as the City of Nadiad;

NOW, THEREFORE,-

- (i) in exercise of the powers conferred by the article 243Q read with sub - section (1) of section 5 of the Gujarat Provincial Municipal Corporations Act, 1949 (Bom. LIX of 1949) (hereinafter referred to as 'the said Act'), the Government of Gujarat hereby constitutes on and from the 01<sup>st</sup> January, 2025, the Municipal Corporation of the City of Nadiad comprising of the said larger urban area and such area shall form the City of Nadiad;
- (ii) in exercise of the powers conferred by sub – section (3) of section 1 of the said Act, the Government of Gujarat hereby specifies 01<sup>st</sup> January, 2025 as the date on and from which the remaining provisions of the said Act shall come into operation in the Municipal Corporation of the City of Nadiad;
- (iii) in exercise of the powers conferred by paragraph 22 and 22B in Part IV of Appendix IV under section 493 of the said Act, the Government of Gujarat hereby appoints Shri Amit Prakash Yadav, IAS to be an Administrator of the Municipal Corporation of the City of Nadiad for the period of one year commencing from the 01<sup>st</sup> January, 2025 or till the councillors are elected in the first election of the said Municipal Corporation, whichever is earlier.

FURTHER, the Government land situated within the area of Nadiad Municipality and Gram Panchayats mentioned in Schedule under the said Notification shall not vest in the Municipal Corporation of the City of Nadiad.
